**APPLICATION:**

The Department of Health Sciences is now accepting applications for the Professional Training Component of the Neurodiagnostic Technology Program for Summer 2025. The deadline for application is March 31, 2025 at 5:00 p.m.

This is a general information sheet that will serve as a reference for you regarding the requirements and procedures involved in the application process and acceptance into the Professional Training Component. Admission to the Professional Training Component is competitive. The factors considered in selection for appointment to the Professional Training Component are academic success, preparation for and understanding of the demands of the profession and program, good communication and interpersonal skills, understanding of a team environment, reliability, good organizational and time management skills, and the ability to deal with stressful situations.

**GENERAL INFORMATION:**

This information sheet does not take the place of a discussion with your individual advisor. Consistent with the admissions policy statement in the University of Holy Cross Catalog, the Department of Health Sciences admits qualified applicants without discrimination in regard to race, color, religion, sex, ethnicity, national origin, handicap, marital status, or veteran's status.

1. It is your responsibility to view Self Service to make sure that all academic requirements are filled before your application is submitted. All prerequisites must be successfully completed before the Summer 2018 semester begins (unless the selection committee grants a specific exemption on an individual basis). For a complete list of courses, please view University of Holy Cross Catalog on the College web site.
2. You must have a minimum cumulative GPA of 2.5 on a 4.0 scale.

3. Admission to the Professional Training Component is on a competitive basis. Attainment of the minimum acceptable credit hours and GPA does not guarantee admission to the Professional Training Component.
4. You must submit a completed application form. The application form is available online and is to be submitted online with the exception of the 3 references, which should be mailed to the Department by the individual providing the recommendation.
5. You need to obtain three letters of reference from academic or supervisory sources such as instructors, advisors/ counselors, or employers. Forms provided in the application packet must be used and may be mailed by the evaluator or submitted in sealed envelope with the evaluator's signature across the seal. **FRIENDS, FAMILY, COWORKERS, AND MEMBERS OF THE CLERGY MAY NOT BE USED AS REFERENCES.**
6. The transfer student applicant is responsible for having official copies of all college transcripts sent to University of Holy Cross. If you are already attending University of Holy Cross and your original transcripts from other colleges or universities have already been sent and are part of your permanent record in the Registrar's office there is no need to send in an additional set of transcripts for the application packet.
7. Follow the checklist that has been provided in the application packet. Submit this with your application.
8. Applicant interviews will be held during the last two weeks of April 2025.
